PRODUCT DESCRIPTION: A rich tomato and cheese broth loaded with chicken and Mexican spices. Garnish this with crumbled tortilla chips, shredded cheese and more!

PREPARATION INSTRUCTIONS:

BOIL-IN-BAG METHOD

- 1) PLACE UNOPENED BAG OF PRODUCT IN LARGE KETTLE OF WATER. BRING TO BOIL
- 2) COOK UNTIL PRODUCT REACHES 170°F 180°F. (77°C 82°C). Hold 10 MINUTES.
- **3)** INTERNAL TEMPERATURE CAN BE CHECKED BY REMOVING BAG FROM WATER; FOLD THE UNOPENED BAG AROUND A STEMMED THERMOMETER.
- 4) TRANSFER TO SERVING CONTAIN, HOLD AT 150 160F (66°C 71°C) UNTIL SERVED.

CONVENTIONAL METHOD

- 1) Thaw product under refrigeration.
- 2) Cut corner of bag and pour product into top portion of a double boiler or container for heating.
- 3) Cook product to 170°F 180°F, (77°C 82°C). WHILE GENTLY STIRRING WITH A SPOON OR WIRE WHIP; CHECK TEMPERATURE; HOLD FOR 10 MINUTES.
- 4) Transfer to serving container, hold at 150°F 160°F (66°C 71°C) UNTIL SERVED.

<u>T - Military Time</u> –	4 digits w/ colon
