### PHYSICAL/CHEMICAL SPECIFICATIONS

Organoleptic - typical distinctive processed sweet potato flavor

Color - a bright, golden color with little color variation

Texture - uniformly smooth, firm but yielding, not mushy

Brix - not less than 18° (light syrup)

Unit Size – approximately 2 oz per unit. Typically size range will exceed 1:3

Unit Count for #10 - approximately 30 to 40 units per can

Defects - total blemished units not greater than 15% by count

Container vacuum - 6 inches (mercury) minimum

#### PREPARATION & MICROBIOLOGICAL CHARACTERISTICS

Commercially Sterile

Canned whole sweet potatoes are prepared from fresh, sound tubers of the *Ipomoe abatatas* sweet potato plant. The tubers are dry-cleaned, washed, peeled with steam, inspected for defects, cut and trimmed, washed again, sized, filled into cans with syrup and heat-processed in a retort to produce a commercially sterile product. Grown and processed in the USA. Kosher Certified.
