- a) Roquette certifies that this product meets all requirements for APP intended for use in foods manufactured for Child Nutrition Programs as described in Appendix A of 7 CFR 210, 220, 225, and 226.
- b) Roquette certifies that this product has been processed so that some portion of the non-protein constituents have been removed by fractionating. This product is produced from the yellow pea by removing the majority of the non-protein constituents.
- c) The true protein digestibility of NUTRALYS® pea protein is 97%. The Protein Digestibility Corrected Amino Acid Score (PDCAAS) for this product is 0.81. It was calculated by multiplying the lowest amino acid score by true protein digestibility as described in the Protein Quality Evaluation Report from the Joint Expert Consultation of the Food and Agriculture Organization/World Health Organization of the United Nations, presented December 4-8, 1989 in Rome, Italy. The PDCAAS is required to be greater than 0.8 (80% of casein).
- d) The protein level by weight of this product is at least 18% when hydrated at a ratio of 3.33 parts water to one part product.
- e) The protein level of this product is certified to be at least 78.0% on an "as is" basis as purchased.
