Preheat to 400° F. Heat for 40-45 minutes from frozen.

Steam

Place entire bag in perforated hotel pan. Heat for 55-60 minutes from frozen.

Other Method

Individual Preparation: Place product on sheet pan uncovered.

Convection Oven

Preheat to 350° F. Heat for 8-11 minutes from frozen.

Conventional Oven

Preheat to 350° F. Heat for 11-14 minutes from frozen.

For best results, heat covered. Note heating times will increase.
