Appearance

- Typical of cooked pork shanks
- Side muscle to be removed

Texture

- Firm, yet tender and juicy

- Typical of cooked, marinated pork

Process

- Fully Steamed Cooked
- Packaged
- Frozen

Packaging

- Vacuum bag
- 12 pieces per pouch
- Label placed centered on each bag
- Product is arranged in a single layer in the bag
- Product is bagged neatly and packed flat in the case
- Shipper label firmly affixed on end panel

Weight

- Piece – target 4-4.5 oz
- Package – approx. 3 lbs
- Case – 9.00 lbs net weight
- Slight variation in piece weights are possible due to normal process variance, however, average weights per box will meet or exceed the stated weight

- Case dimensions 11.250" x 9.750" x 5.438"
- Outside cubic feet 0.345
- Packages per case 3
- Cases per pallet 120
- Stack pattern 15/layer by 8/high

- “Julian” code date on package and shipper in DDDY format
- Lot designation
