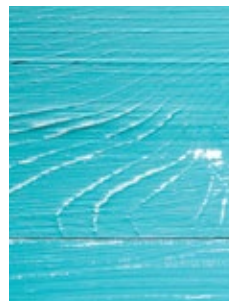

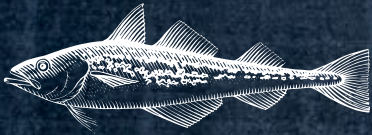

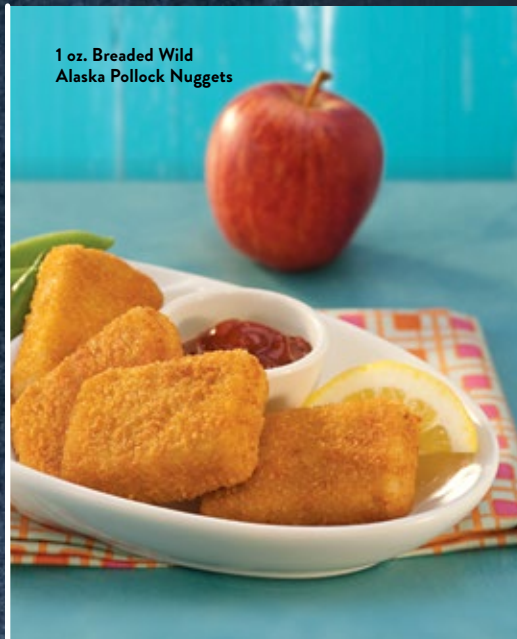

Convection oven: Preheat to 400° F. Place frozen product on lightly greased baking sheet, cook for 8 to 12 minutes until crisp. Turn product halfway through bake time for best results.

Microwave cooking is not recommended.
